

Subject: Notice for Departmental Research Committee (DRC) meeting to be held on 24.08.2022

Departmental Research Committee (DRC) of CSE Department will meet on 24.08.2022 from 09:30 am in office of Chairman, CSED to evaluate the eligible candidates for admission in Ph.D. programme in Computer Science and Engineering through presentation/viva-voce/interview.

All eligible candidates who have qualified the Entrance Test conducted in session 2022-23 or otherwise exempted under Clause 3.5 (PhD Prospectus 2022-23) are eligible to appear before DRC. ***The candidates, who qualified the entrance test conducted in July, 2021 are also eligible for admission, however, they must have registered a fresh for admission in academic session 2022-23_Odd Semester.*** These includes the candidates who have valid JRF (UGC/CSIR/DBT/any other through an Entrance Test)/GATE/NET or have secured atleast 50% marks in case of General Category and atleast 45% marks for the candidates belonging to SC /BC (Non-Creamy layers)/ Differently-abled category in the entrance examination conducted by the University. **(Minimum qualifying marks do not guarantee the admission.)**

Candidates shall bring two sets of attested/self-attested copies of following documents (as applicable) at the time of counseling/presentation for admission in Ph.D. Programmes:

- Print out of **Online Application form** with **three photographs** pasted on the form
- University **Entrance Test Result Card/ Valid JRF/NET/GATE Card**
- Certificates showing the **detailed marks in all subjects in the qualifying examination**
- **Conversion table/formula** showing equivalence between percentage and CGPA of the qualifying degree.
- **Matriculation/Hr Secondary examination certificate** as proof of age.
- **Medical Fitness Certificate** from a Gazetted Medical Officer
- **Character Certificate (Annexure I)**. For gap period, if any, the candidate will submit an Affidavit from the notary/first class magistrate certifying his/her good conducts.
- **Haryana Resident Certificate (Annexure II)** (Applicable for HOGC/SC/BC-A/BC-B/PH/EWS categories only)
- **SC/BC-A or BC-B (OBC is not valid)/PH (Annexure -IV, V, VI, VII) category Certificate**
- **Creamy layer certificate (for BC category Only)**
- **Certificate from the employer (Annexure-III)**
- **Income certificate from competent authority (Annexure-XI)** (For BC and EWS categories only)
- **Economically Weaker Section: Income and assets certificate** applicable for the state of Haryana (Annexure-XII)
- **Declaration by parents (Annexure VIII)**
- **Sponsorship Certificate (Annexure IX)** (for candidates in service only)
- **Relieving Certificate (Annexure X)** (for candidates in service only)
- **Family ID/Parivar Pehchan Patra**
- **Aadhar Card**
- **Fee Receipt**

Candidates may also submit the proofs of their research contribution (if any).
