For the Fourth counseling of B.Sc.-M.Sc. (DD) (Biotechnology) programed on 01/08/2024, all eligible candidates (as per the eligibility conditions mentioned in UG admission Prospectus-2024-25) are directed to report in the Department of Biotechnology at 9:00 A.M. in Bioinformatics lab JCB-Block First floor, along with all documents in original along with two sets of photocopies and three passport size photographs.

The Procedure for 4th/5th/6th Counseling shall be as under:

If the list of candidates appeared in the Entrance Test conducted by University is exhausted then the following procedure will be followed, otherwise candidates from the merit list of Entrance Examination will only be considered.

- Already registered candidates can also participate in these counseling and need not to apply again.
- Unregistered candidates need to fill an application form which is available at page no. 35 – 36 of Prospectus.
- Time for marking of attendance and submission of applications form is 9:30 a.m. to 11:30 a.m. in the respective departments.
- For these counseling, no applications shall be accepted after 11: 30 a. m.
- All admitted candidates shall be charged University Fee as given in Prospectus on the day of counseling. Unregistered candidates shall have to pay an additional charge of Rs.1000/- as Registration Fee in addition to the fee mentioned in prospectus.

Seats shall be filled through following sequence (order of preference) for all counseling:-

- Firstly, the eligible candidates will be considered on merit of valid GATE score (wherever applicable) for admission.
- After exhausting (criteria a), eligible candidates will be considered for admission based on the merit list of results of entrance tests conducted by the University.
- After exhausting (criteria b), eligible candidates will be considered for admission on the basis of the merit list of **qualifying examination**.
- Thereafter, if the seats still remain vacant, chance will be given to those who have cleared their all

examinations upto pre final year/semester and appeared in final exam. Their relative merit shall be formed on the basis of their average % of marks up to pre final year/semester (% marks should be equal or more than given in Chapter-1 under eligibility conditions). Proof of qualifying final exam should be submitted (should fulfill the eligibility conditions as given in Chapter-1), otherwise admission shall stand cancelled automatically and all the dues/fees paid by them shall be forfeited.

Criteria for filling of reserved seats:

- The vacant seats of reserved category will be filled by the candidates of respective category.
- However, if reserved category candidates are not available on the day of counseling (till 11.30 a.m.), the seats will be filled by General Category (All India basis).
- Supernumerary seats (EWS Quota, SQ, UEQ, SGCQ and KM) are over and above sanctioned intake and cannot be converted into any other category.
